CITY OF WATFORD CITY CITY COUNCIL MEETING April 3, 2023

Minutes of the regular City Council meeting held on April 3, 2023 at 6:00 p.m. at City Hall. Present were Mayor Phil Riely and Council Members Bethany Devlin, Kenny Liebel, Matt Beard, Steve Sanford, Chelsea Bulzomi, and Lance Renville. Also present was City Administrator Curt Moen, City Auditor Peni Peterson, and City Attorney Wyatt Voll. Mayor Riely called the meeting to order with the Pledge of Allegiance.

Our special guest for tonight's council meeting was Evan Jacobson who was chosen the "Mayor for the Day" from Mrs. Brickner's 3rd grade class. Mayor Jacobson shared with the city council members his essay which earned him the title as "Mayor for the Day".

Council Member Beard moved to approve the April 3, 2023 agenda, as presented. Motion seconded by Council Member Sanford and carried unanimously.

Council Member Liebel moved to approve the minutes of the city council meetings held March 6 and March 21, 2023 with a correction to the March 6th minutes regarding the Chamber request to hold Rib Fest at the RRC. Minutes should reflect it was not a unanimous vote but carried with Liebel voting nay. Motion seconded by Council Member Devlin and carried unanimously.

Aiden Pelton presented an update from the WCHS Student Ambassador program.

Sara Fitzpatrick gave an update on the Roughrider Center.

Travis Rodenhizer and Tony Carmichael gave an update on the Fox Hills Golf Course.

Chief Wellen gave an update on the police department.

Council Member Sanford moved to approve the recommendations from the Planning Commission meeting held March 27, 2023. Approved: Land Use Application – Zone Change Application submitted by Hansen Diesel & Automotive and a Division of Land Application – Minor Plat for Simple Lot Split submitted by WC 16, LLC. Motion seconded by Council Member Renville and carried by the following roll call vote: ayes: Sanford, Liebel, Devlin, Bulzomi, and Renville; nays: none.

Council Member Sanford moved to approve Invoice #10 from Steve Dube Construction (Long X Visitors Center Remodel Project) in the amount of \$40,000. Motion seconded by Council Member Bulzomi and carried by the following roll call vote: ayes: Sanford, Liebel, Devlin, Beard, Bulzomi, and Renville; nays: none.

Council Member Beard moved to approve Task Order #9 from Steve Dube Construction in the amount of \$11,815. Motion seconded by Council Member Renville and carried by the following roll call vote: ayes: Bulzomi, Sanford, Liebel, Devlin, Renville, and Beard; nays: none.

Council Member Renville moved to approve Task Orders 11 & 12 from Steve Dube Construction in an amount not to exceed \$5000 and based on time and materials. Motion seconded by Council Member Sanford and carried by the following roll call vote: ayes: Renville, Sanford, Beard, Devlin, Liebel, and Bulzomi; nays: none.

Council Member Beard moved to approve the Second Reading on Ordinance #602 Amending Chapter XVI - relating to Reservation Telephone Cooperative General Communication and Cable Television. Motion seconded by Council Member Bulzomi and carried by the following roll call vote: ayes: Bulzomi, Liebel, Sanford, Beard, Renville, and Devlin; nays: none.

Council Member Beard moved to allow Enhancement Grant Applications until the end of the year, or until the fund balance has been depleted, as recommended by the Rough Rider Committee. Motion seconded by Council Member Bulzomi and carried unanimously.

Council Member Devlin moved to approve the annual step increases for: Kaitlyn Swearson K-1; Daniel Barry G-1; Amanda Eisenschenk J-7; Andrew Eisenschenk F-7; Steve Williams E-10; Sam Forstie F-1. Motion seconded by Council Member Liebel and carried unanimously.

Council Member Liebel moved to hire for an additional Community Service Officer to be placed at the Rough Rider Center. Motion seconded by Council Member Bulzomi and carried by the following roll call vote: ayes: Sanford, Beard, Renville, Devlin, Liebel, and Bulzomi; nays: none.

Council Member Liebel moved to approve the Airport Authority request to use their 2022 budget allocation of \$50,000 in 2023 as it did not get used in 2022. Motion seconded by Council Member Devlin and carried by the following roll call vote: ayes: Beard, Renville, Sanford, Devlin, Liebel, and Bulzomi; nays: none.

Council member Devlin moved to approve the Golf Course Jr. Golf Program requests totaling \$23,043.53. Funds will be paid with donations that were made to the Junior Golf Program. Motion seconded by Renville and carried by the following roll call vote: ayes: Liebel, Sanford, Beard, Devlin, Renville, and Bulzomi; nays: none.

Council Member Devlin moved to approve the Lodging Tax request submitted by the Long X Visitor Center/Pioneer Gift shop in the amount of \$3,750 and to deny the McKenzie County Tourism request in the amount of \$1,500. Motion seconded by Council Member Beard and carried by the following roll call vote: ayes: Renville, Devlin, Beard, Bulzomi, Liebel, and Sanford; nays: none.

Council member Sanford moved to recommend Mayor Riely sign the Letter of Support regarding Judgeship No. 3 Vacancy NW Judicial District. Motion seconded by Council Member Liebel and carried unanimously.
