CITY OF WATFORD CITY CITY COUNCIL MEETING October 02, 2023

Minutes of the regular City Council meeting held on October 2, 2023 at 6:00 p.m. at City Hall. Present were Mayor Phil Riely and Council Members Lance Renville, Steve Sanford, Matt Beard, and Chelsea Bulzomi. Absent was Bethany Devlin and Kenny Liebel. Also present was City Administrator Curt Moen, City Auditor Peni Peterson, and City Attorney Wyatt Voll. Mayor Riely called the meeting to order with the Pledge of Allegiance.

Council Member Renville moved to approve the October 2, 2023 meeting agenda, as presented. Motion seconded by Council Member Sanford and carried unanimously.

Council Member Bulzomi moved to approve the minutes of the city council meeting held September 6, 2023. Motion seconded by Council Member Renville and carried unanimously.

Attorney Howard Swanson gave an update on the Hunters Run Settlement and provided a Settlement Agreement and Mutual Release between the City of Watford City, Hunters Run, LLC, and Touraj Jason Vedadi.

Council Member Renville moved to prove the terms of the Settlement Agreement and Mutal Release between the City of Watford City, Hunters Run, LLC, and Tourai Jason Vedadi and to allow city officials to sign the agreement. Motion seconded by Council Member Beard and carried by the following roll call vote: ayes: Beard, Bulzomi, Renville, and Sanford; nays: none.

Moved by Council Member Bulzomi that the following resolution be adopted: Whereas, the City Council did on the 7th of August 2023 adopt a preliminary budget for January 1, 2024 through December 31, 2024, and that the budget notice of the final hearing to be held at this time and place was published; Therefore, be it resolved that the Final Budget be adopted, and the following amounts be levied: General Fund \$1,446,979; Emergency \$40,000; Cemetery \$63,000 Lease of Law Enforcement Facilities \$142,100 totaling \$1,692,079. Motion seconded by Council Member Sanford and carried by the following roll call vote: ayes: Beard, Sanford, Bulzomi, and Renville; nays: none.

Sara Fitzpatrick gave an update on the Roughrider Center.

Tony Carmichael & Travis Rodenhizer gave an update on the Fox Hills Golf Course.

Chief Wellen gave an update on the police department.

Council Member Beard moved to approve the Land Use Application – Zone Change submitted by Alquist Welding rezoning property located at 1420 11th Ave SE from A-2 to Industrial. Motion seconded by Council Member Renville and carried by the following roll call vote: ayes: Bulzomi, Renville, Sanford, and Beard; nays: none.

Council Member Bulzomi moved to approve the Land Use Application – Zone Change submitted by Northern States Fishing Tools rezoning property located at 1004 4th St SW from A-2 to Industrial. Council Member Beard moved to deny the Land Use Application – Zone Change submitted by Jerry Foley for property located at 605 Main St S. The current zoning for the property is C-1 General Commercial and rezoning to Industrial would be difficult as mixing industrial traffic with commercial/public traffic on the shared access road is inappropriate and unsafe. The site development did not take into account heavier industrial use in terms of road design, traffic separation, or similar.
