Thank you for your interest in the **2023 Roughrider Fund Community Enhancement Grant** Program.

For 2023, the Watford City City Council and Roughrider Fund committee have allocated funds for nonprofit groups and organizations to fund activities and projects that improve the quality of life in and around the Watford City area.

Grant recipients in 2022: Badlands Gymnastics, LAND, Long X Arts Foundation, Bakken Oil Rush, Trap, Neuter & Rescue Foundation, Watford City After Prom Committee, Watford City Homefest, Light Up Watford City, Best of the West Ribfest, Watford City Downtown Association, McKenzie County Heritage Park, Farm Rescue, Alexander After Prom Committee, Alexander Comets Youth Wrestling Club, & Arnegard Rural Fire District.

The Community Enhancement Grant program is made possible through the Watford City Roughrider Fund. The Roughrider Fund was created to help support economic and community development of the community through a voter approved 1.5% city sales tax. The Community Enhancement Grant program supports area vibrancy and sustainability through annually funding programs and projects in Alexander, Arnegard, Keene, Grassy Butte, Mandaree, and Watford City.

The **MAXIMUM** grant amount for communities in McKenzie County (Alexander, Arnegard, Keene, Grassy Butte, Mandaree & 5 at large applications throughout the County) is **\$2,500** for the Community Enhancement Grant.

The **MAXIMUM** grant amount for applications within Watford City is **\$ 3,000** for the Community Enhancement Grant.
