We are pleased to provide you with our *Annual Drinking Water Quality Report* for the year 2018. The City of Watford City and its staff want to keep you informed about the water and services we have delivered to you over the past year. Our goal is to provide you with a safe and dependable supply of drinking water. We purchase our water from the city of Williston.

Our public water system, in cooperation with the North Dakota Department of Health, has completed the delineation and contaminant/land use inventory elements of the North Dakota Source Water Protection Program. Based on the information from these elements, the North Dakota Department of Health has determined that our source water is “*moderately susceptible*” to potential contaminants.

Watford City wants its residents to be informed about their water utility. The City Council is the governing body for our water system. You are welcome to attend any regularly scheduled meeting to express any concerns or recommendations. They are held on the first Monday of every month at 6:00 p.m. in the Heritage Room at City Hall. City Hall is located at 213 2nd St., NE. If you are aware of non-English speaking individuals who need help with the appropriate language translation, please contact Justin Smith at the number or address above.

The City of Watford City would appreciate it if large volume water users such as hotels, motels, apartments, hospitals, elderly care facilities, schools, etc. would please post copies of the *2018 Annual Drinking Water Quality Report* in conspicuous locations or distribute them to tenants, residents, patients, students, and/or employees, so individuals who consume the water, but do not receive a water bill, can learn about our water system.

Watford City routinely monitors for contaminants in your drinking water per Federal and State laws. The table contained within this report shows the results of our monitoring for the period of January 1st to December 31st, 2018. As authorized and approved by the United States Environmental Protection Agency, the state has reduced monitoring requirements for certain contaminants to less often than once per year because the concentrations of these contaminants are not expected to vary significantly from year to year. Some of our data (e.g., for inorganic contaminants), though representative, is more than one-year-old.

The sources of drinking water (both tap and bottled water) include rivers, lakes, streams, ponds, reservoirs, springs, and wells. As water travels over the surface of the land, or through the ground, it dissolves naturally occurring minerals and, in some cases, radioactive material, and can pick up substances resulting from the presence of animals or from human activity.

Contaminants that may be present in source water include:

Microbial contaminants, such as viruses and bacteria, which may come from sewage treatment plants, septic systems, agricultural livestock operations and wildlife.

Inorganic contaminants, such as salts and metals, which can be naturally-occurring or result from urban storm water, industrial or domestic wastewater discharges, oil production, mining or farming.

Pesticides and herbicides, which come from a variety of sources such as agriculture, urban storm water runoff and residential uses.

Organic chemical contaminants, including synthetic and volatile organic chemicals, which are by-products of industrial processes and petroleum production, and can, also, come from gas stations, urban storm water runoff and septic systems.

Radioactive contaminants, which can be naturally-occurring or be the result of oil and gas production and mining activities.

To ensure that tap water is safe to drink, the Environmental Protection Agency (EPA) prescribes regulations which limit the number of certain contaminants in water provided by public water systems.

The Food and Drug Administration (FDA) regulations establish limits for contaminants in bottled water which must provide the same protection for public health.

In the following table, you will find many terms and abbreviations you might not be familiar with. To help you better understand these terms we've provided the following definitions:

Not applicable (NA), No Detect (ND)

Parts per million (ppm) or Milligrams per liter (mg/l) - one part per million corresponds to one minute in two years or a single penny in \$10,000.

Parts per billion (ppb) or Micrograms per liter ($\mu\text{g/l}$) - one part per billion corresponds to one minute in 2,000 years, or a single penny in \$10,000,000.

Picocuries per liter (pCi/l) –Pico curies per liter is a measure of the radioactivity in water.

Action Level (AL) - the concentration of a contaminant which, if exceeded, triggers treatment or other requirements which a water system must follow.

Treatment Technique (TT) - A treatment technique is a required process intended to reduce the level of a contaminant in drinking water.

Maximum Contaminant Level - The “Maximum Allowed” (MCL) is the highest level of a contaminant that is allowed in drinking water. MCLs are set as close to the MCLGs as feasible using the best available treatment technology.

Maximum Contaminant Level Goal - The “Goal” (MCLG) is the level of a contaminant in drinking water below which there is no known or expected risk to health. MCLGs allow for a margin of safety.

Maximum Residual Disinfectant Level (MRDL) – The highest level of a disinfectant allowed in drinking water. There is convincing evidence that addition of a disinfectant is necessary for control of microbial contaminants.

Maximum Residual Disinfectant Level Goal (MRDLG) – The level of a drinking water disinfectant below which there is no known or expected risk to health. MRDLGs do not reflect the benefits of the use of disinfectants to control microbial contaminants.

2018 Consumer Confidence Report - System Assessment Information and Corrective Actions Required Under the Revised Total Coliform Rule (RTCR)

City of Watford City; Public Water System (PWS) Number ND2700990.

- Our system is required to monitor monthly for total coliform bacteria in our drinking water. Coliforms are bacteria that are naturally present in the environment and are used as an indicator that other, potentially harmful, waterborne pathogens may be present or that a potential pathway exists through which contamination may enter the drinking water distribution system. We found coliforms indicating the need to look for potential problems in water treatment or distribution. When this occurs, we are required to conduct assessments to identify problems and to correct any problems that were found during these assessments.
- A Level 1 assessment is a study of the water system to identify potential problems and determine (if possible) why total coliform bacteria have been found in our water system.
- During the past year we were required to conduct one Level 1 assessment. One Level 1 assessment was completed.
- January 2018 had the highest number of positive Total Coliform samples. Two samples were positive for that month. The Level 1 assessment was triggered on January 17, 2018. The assessment was completed on 1/29/2018.
- **Corrective Actions: Changed sampling location to a more suitable location. Began flushing water in building every other month. Utilized special purpose sampling to find that a valve had inadvertently been left closed after maintenance. Began on-going training to verify all valves are open during and after seasonal fire hydrant flushing, as well as opened after construction events. Corrected: On-going**
- Subsequent bacteriological samples have been satisfactory.

Surface Water Treatment Rule Monitoring Data:

Bacteriological Monitoring Data-RTCR: January had the highest number of Total Coli Form Samples. **Total Coli Form Positives for that month:** (2) of samples collected Coli forms are bacteria that are naturally present in the environment and are used as an indicator that other potentially-harmful, bacteria may be present.

EPA requires monitoring of over 80 drinking water contaminants. Those contaminants listed in the table above are the only contaminants detected in your drinking water.

*If present, elevated levels of lead can cause serious health problems, especially for pregnant women and young children. Lead in drinking water is primarily from materials and components associated with service lines and home plumbing. Watford City is responsible for providing high quality drinking water, but cannot control the variety of materials used in plumbing components. **Use water from the cold tap for drinking and cooking. When your water has been sitting for several hours, you can minimize the potential for lead exposure by flushing your tap for 30 seconds to 2 minutes before using water for drinking or cooking.** If you are concerned about lead in your drinking water, you may wish to have your water tested. Unregulated contaminants are those for which EPA has not established drinking water standards. The purpose of unregulated contaminant monitoring is to assist EPA in determining the occurrence of unregulated contaminants in drinking water and whether future regulation is warranted.

Drinking water, including bottled water, may reasonably be expected to contain at least small amounts of some contaminants. The presence of contaminants does not necessarily indicate that the water poses a health risk. MCL's are set at very stringent levels. To understand the possible health effects described for many regulated contaminants, a person would have to drink 2 liters of water every day at the MCL level for a lifetime to have a one-in-a-million chance of having the described health effect.

Some people may be more vulnerable to contaminants in drinking water than the general population. Immuno-compromised persons, such as: persons with cancer undergoing chemotherapy, persons who have undergone organ transplants, people with HIV/AIDS or other immune system disorders, some elderly, and infants can be particularly at risk from infections. These people should seek advice about drinking water from their health care providers.
